**CANCELLATIONS:** There are no refunds for FEI entries. Any other cancellations, with regards to refunds will be handled on an individual basis. There is no guarantee on a full refund. NO REFUNDS will be issued until 10 days post ride.

ALL ENTRANTS MUST SHOW A CURRENT YEAR AERC MEMBERSHIP CARD AT THE RIDE OR PAY A \$15 AERC NONMEMBER FEE (A photocopy of the card may be sent with the entry form). Please include your ECTRA Rider & Horse Membership numbers where applicable on the entry form.

**COGGINS & RABIES INOCULATIONS:** All entries must show a negative Coggins within a 12 month period. All horses must have a current rabies certificate issued by a **veterinarian** within 12 months of the ride date. Rabies is endemic in this area and this is for your horse's protection. All companion animals that come with you **must** also have proof of current rabies vaccination.

DOGS MUST BE CONFINED OR LEASHED AT ALL TIMES FOR SAFETY REASONS!!!!! If your dog is loose, you may be asked to leave the grounds!

**GROUNDS:** Parking available in an open farm field. Only rough camping facilities are available. Portable toilets will be provided but there are no shower facilities. Water will be available for horses only. Bring drinking water and additional water for your horse in case of a dry spell. If you plan to arrive prior to Thursday, Oct. 5<sup>th</sup>, please check with the ride manager.

**TRAIL:** The footing is sandy, with minimal deep, sugar sand. Trails will be single-track fire trails, wide trails, and sandy roads.

**COMPLETION TIMES:** Please refer to the FEI schedule that is listed on the FEI website. Please make sure you read this, the ride times for each distance is different.

**RIDE BRIEFING:** ZOOM meeting will be held on 10/4/2023 at 7pm. In person on 10/6/23, after vetting is completed approximately 6:30 p.m.

**FARRIER/TREATMENT VET:** A farrier and treatment vet will be available at rider expense. PLEASE... before leaving the ride make arrangements for payment of any veterinary and/or farrier expenses incurred.

**VETTING:** Pre-ride vetting will be completed for horses by Friday, October 6<sup>th</sup> **There will be no morning vetting.** All horses must be vetted the day before the rides!

**AWARDS:** First to Finish, Best Condition, Top Ten, Completion.

**VETERINARIANS: TBA** 

**HELMETS:** ASTM/SEI helmets are required by all riders and must be properly fastened when mounted.

**JUNIOR/YR RIDERS**: Junior/young rider under the age of 16 must ride with their sponsor at all times. If the sponsor must withdraw, the junior must also withdraw unless another sponsor can be found. All junior riders, regardless of age, who do not have 500 miles of competition completed, must also ride with a sponsor and withdraw if the sponsor withdraws unless another sponsor can be found.

**VOLUNTEERS:** NJTRA encourages family participation at all events and can use the support of "helping hands" to ensure a safe, enjoyable ride. Areas of need include (but are not limited to) water crew, P&R crew, trail hospitality, grounds upkeep/cleanup, message runners / go-fers, radio crew, road crossing spotters, and junior membership helpers. Please call or email the ride secretary if there is anyone accompanying you who would be willing to volunteer for a job at the ride.

**MEALS:** Riders will be served dinner Friday, 10/6/23. To order additional meals for your crew indicate the number of meals and which days on the pricing table on page one of this entry form. Extra meals are \$15 each and must be ordered by September 27th and include payment in full with entry.

**Corrals:** Management reserves the right to ask any rider to leave if your horse(s) are not properly contained. Riders are responsible for properly securing their horses at the ride site. With regard to electric fences, bear in mind that many horses will be blanketed at this time of year and are not likely to feel the electricity through the blanket. The NJTRA board strongly advises that your top electric tape be about nose height to your horse (about 4 feet). Portable corral panels are available at \$10/panel, on a **first come first serve basis**, for you to set up. **To reserve panels** indicate the number of panels required as well as the day(s) you will be renting them on the pricing table on page one of this entry form. Orders must be received, with payment in full with entry. Ride camp is an open farm field and all horses need to be secure.

ACKNOWLEDGMENT OF RISK: I knowingly, willingly, and voluntarily acknowledge the inherent risks associated with the sport of equestrian and know that horseback riding and related equestrian activities are inherently dangerous, and that participation in any USEF Event involves risks and dangers including, without limitation, the potential for serious bodily injury (including broken bones, head or neck injuries), sickness and disease (including communicable diseases), trauma, pain & suffering, permanent disability, paralysis and death; loss of or damage to personal property (including my mount & equipment) arising out of the unpredictable behavior of horses; exposure to extreme conditions and circumstances; accidents involving other participants, event staff, volunteers or spectators; contact or collision with other participants and horses, natural or manmade objects; adverse weather conditions; facilities issues and premises conditions; failure of protective equipment (including helmets); inadequate safety measures; participants of varying skill levels; situations beyond the immediate control of the USEF Event organizers and competition management; and other undefined, not readily foreseeable and presently unknown risks and dangers ("Risks").

WAIVER AND RELEASE OF LIABILITY, HOLD HARMLESS AND INDEMNITY: In conjunction with my participation in any USEF Event, I hereby release, waive and covenant not to sue, and further agree to indemnify, defend and hold harmless the following parties: USEF, USEF Recognized Affiliate Associations, the United States Olympic & Paralympic Committee (USOPC), USEF clubs, members, Event participants (including athletes/riders, coaches, trainers, judges/officials, and other personnel), the Event owner, licensee, and competition managers; the promoters, sponsors, or advertisers of any USEF Event; any charity or other beneficiary which may benefit from the USEF Event; the owners, managers, or lessors of any facilities or premises where a USEF Event may be held; and all directors, officers, employees, agents, contractors, and volunteers of any of the aforementioned parties (Individually and Collectively, the "Released Parties" or "Event Organizers"), with respect to any liability, claim(s), demand(s), cause(s) of action, damage(s), loss, or expense (including court costs and reasonable attorney fees) of any kind or nature ("Liability") which may arise out of, result from, or relate in any way to my participation in the USEF Events, including claims for Liability caused in whole or in part by the negligent acts or omissions of the Released Parties.
- E. COMPLETE AGREEMENT AND SEVERABILITY CLAUSE: This Agreement represents the complete understanding between the parties regarding these issues and no oral representations, statements or inducements have been made apart from this Agreement. If any provision of this Agreement is held to be unlawful, void, or for any reason unenforceable, then that provision shall be deemed severable from this Agreement and shall not affect the validity and enforceability of any remaining provisions.

I HAVE CAREFULLY READ THIS DOCUMENT IN ITS ENTIRETY, UNDERSTAND ALL OF ITS TERMS AND CONDITIONS, AND KNOW IT CONTAINS AN ASSUMPTION OF RISK, RELEASE AND WAIVER FROM LIABILITY, AS WELL AS A HOLD HARMLESS AND INDEMNIFICATION OBLIGATIONS.
